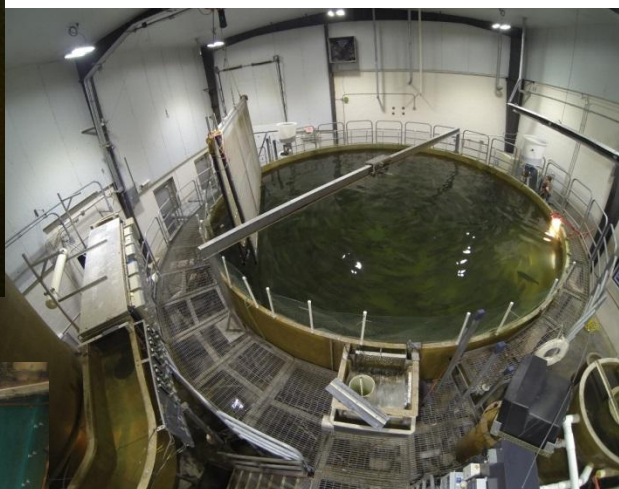


International Seminar on Land-Based Aquaculture Systems

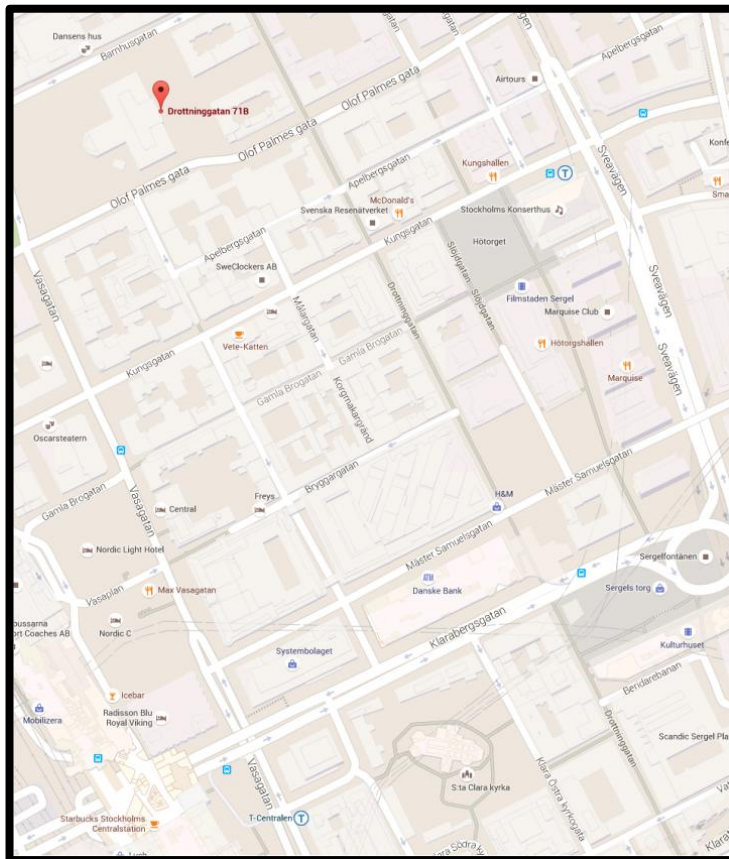
